# Conditions of Membership

- The club shall be called "Le Mirage" and shall be a proprietary Club owned by St Pierre Park Hotel and administered by the Manager of the club (the Manager) or by such persons as the Directors shall nominate.
- Persons wishing to become Members of Le Mirage shall complete the official application form. Applicants are required to submit the duly completed form to the Manager together with payment in respect of the appropriate annual membership fee.
  - Absolute discretion is granted to the Directors to reject any application or renewal of membership without giving any reason for doing so, in such cases monies will be refunded.
  - Membership of Le Mirage shall commence from day of acceptance.
  - Membership shall be renewed annually by the payment to the club of the annual fee in force.
- The Owners shall be entitled without prior notice to vary the times at which any of the facilities are available at any time and for any period in connection with repair, alternation or maintenance of the facilities or other parts of the Hotel or when such facilities are required for the Owners own use in connection with the business of the Hotel.
- Correct footwear and clothing should be worn appropriate to the activity being undertaken. The Management reserves the right to refuse right of use to persons incorrectly dressed.
- The Owners, their agents and employees, will not be liable in any way for the loss of, or damage to, the property of members or guests or for the personal injury to, or death of, any member or guest, howsoever caused. Members or guests using the facilities of the Owners do so entirely at their own risk.
- The Owners shall have the power and the right at any time upon one month's notice to members to discontinue the Club upon refunding to members the unexpired portion of their current subscription.
- By their membership, members accept and agree to be bound by the rules of the Club from time to time in force.
- The Owners in their sole discretion may at any time vary these rules or any entry fee, membership subscriptions or any charges for the use of any or all of these facilities. Notice of such variations shall be given to members by exhibition thereof in prominent positions around the facilities.
- Any dispute or difference which may arise in regard to the interpretation of these shall be determined by the General Manager whose decision shall be final and binding.
